

**The 5th International Research and Practice Conference
“Herzen University Conference on Psychology in Education”
Participation Contract
Offer**

The Herzen State Pedagogical University of Russia, represented by Svetlana A. Pisareva, the Vice-Rector for Research and Innovation, acting pursuant to power of attorney No. 2022-P-17 of 12 April 2022, hereinafter referred to as “Contractor”, in accordance with Article 435 of the Civil Code of the Russian Federation, hereby offers an individual, hereinafter referred to as the “Client”, to enter into a contract (hereinafter the “Contract”) for supply of services under the following terms and conditions:

1. Subject-matter

- 1.1. Contractor shall organise and hold the 5th International Research and Practice Conference “Herzen University Conference on Psychology in Education” (the “Conference”) (hereinafter the “Services”) in accordance with the Programme (available at Herzen University official website: at <https://herzenpsyconf.ru/>), and the Client shall effect payment for these services.
- 1.2. Conference Dates: 25–26 October 2022, Saint Petersburg, Russia.
- 1.3. Conference Venue: 48 Moika Emb., St Petersburg, Russia.

2. Rights and Obligations of the Parties

- 2.1. The Contractor shall
 - 2.1.1. provide services in full under this Contract;
 - 2.1.2. upon provision of the services, issue the Certificate of Services Rendered and the invoice to the Client.
- 2.2. The Client is entitled to
 - 2.2.1. request information in regards to the organisation and ensuring proper provision of services under Section 1 of this Contract from the Contractor;
- 2.3. The Client shall
 - 2.3.1. before the date of the Conference, send the Contractor a copy of a document confirming payment for services under this Contract at the following email address: a.miklyaeva@gmail.com;
 - 2.3.2. accept properly rendered services, sign relevant services acceptance documents.

3. Price and Payment

- 3.1. The cost of services (price of the Agreement) is 1,800 (One thousand eight hundred) rubles, including VAT 20% – 300 rubles, and includes participation in the Conference of 1 (one) person (with receipt of an electronic certificate) with an oral report and publication of materials in the electronic collection of the Conference.
- 3.2. The cost of services (price of the Agreement) is 600 (Six hundred) rubles, including VAT 20% – 100 rubles, and includes participation in the Conference of 1 (one) person (with receipt of an electronic certificate) with an oral report without publication of materials in electronic collection of the Conference.
- 3.3. Full payment for the services provided is made by the Client in advance, no later than on the day preceding the first day of the Conference. Payment is made by an individual using a payment form posted at [//herzenpsyconf.ru/](https://herzenpsyconf.ru/). Payment shall be deemed to have been effected upon receipt of funds to Contractor’s account.
- 3.4. The Client makes the payment in accordance with the payment form either in cash or via a wire transfer from a bank office, payment terminal, online banking system or Internet acquiring service (the latter is only available where the Contractor has the technical capacity to ensure payment acceptance). Wire transfer fees are paid by the Client at his own expense.

4. Amendment and Termination

- 4.1. Upon termination of the Contract by the Client, the Contractor shall withhold any incurred expenses.
- 4.2. Any changes or additions to the Contract are made by an Addendum executed by the Parties.

5. Liabilities

- 5.1. The Parties are liable for failure to perform or improper performance of their obligations under this Contract as provided by law of the Russian Federation.
- 5.2. Should the Client discover that the services have not been provided properly or in full, the Client

may exercise his rights in accordance with the laws of the Russian Federation.

6. Contract Term

6.1. In accordance with Articles 433, 438 of the Civil Code of the Russian Federation, this Contract shall come into force upon receipt of payment documents by the Contractor confirming payment of services by the Client (acceptance of the offer) and is valid until the Parties fulfil their obligations in full.

7. Miscellaneous

7.1. In any matter not covered by this Contract, current legislation of the Russian Federation shall apply.

7.2. All disputes arising between the parties are resolved in accordance with the procedure established by the legislation of the Russian Federation.

7.3. This Contract shall be deemed to have been made at the location of the Contractor.

7.4. The Parties recognise the legal force of electronic copies of documents, information transmitted through the Contractor's official website on the Internet, notices, correspondence, documents received / sent to email addresses or other contact details specified in this Contract or in a notice specifying new contact details of one of the Parties.

7.5. By entering into this Contract, the Client consciously consents to the processing of his personal data contained in this Contract for the purposes of its conclusion and proper execution. Personal data is not distributed or provided to third parties without the consent of the data owner. Consent to the processing of personal data remains valid indefinitely and can be revoked by the data owner upon a written notice sent to the Contractor's address.
